ATTORNEY GENERAL LAW ENFORCEMENT DIRECTIVE NO. 2001-7

WHEREAS, the Attorney General has recognized that the public interest would be served by a review of the structure of the law enforcement community in New Jersey;

WHEREAS, the Attorney General has informally assembled a group of individuals who, by virtue of their vast experience and expertise in the area of criminal law enforcement, are uniquely qualified to undertake this review;

WHEREAS, the Attorney General finds that the public interest is furthered through formal memorialization of the membership and function of this group on this important public issue;

NOW, THEREFORE, I, JOHN J. FARMER, JR., ATTORNEY GENERAL OF NEW JERSEY, by virtue of the authority vested in me by the Constitution and by the Statutes of this State, do hereby direct:

1. The Attorney General Advisory Committee ("Committee") is hereby established within the Department of Law and Public Safety to assist and advise the Attorney General on issues concerning the law enforcement structure of New Jersey;

2. The membership of the Committee shall consist of the following individuals:

- a. Attorney General;
- b. John Degnan, Esq.;
- c. Robert Del Tufo, Esq.;
- d. W. Cary Edwards, Esq.;
- e. George Kugler, Jr., Esq.;
- f. Edwin Stier, Esq.;

3. The Attorney General shall act as the Chair of the Committee. The Committee shall meet formally at regular intervals as directed by the Chair. Meetings of the Committee shall also be scheduled within a reasonable time after the Chair's receipt of a request for such a meeting by a majority of its members.

4. The Chair of the Committee may establish such subcommittees as are necessary from time to time. The members of such subcommittees shall be appointed by the Chair.

5. The Committee shall prepare and issue such reports, studies and recommendations that it deems appropriate as a result of its review of the structure of the law enforcement community in New Jersey.

6. The Attorney General shall in his discretion designate such support staff as may be necessary to assist the Committee in its mission.

7. This Directive shall take effect immediately.
