

INDICTMENT

The Grand Jurors of and for the State of New Jersey, upon their oaths, present that:

COUNT ONE

(Theft by Deception-Third Degree)

MAXINE KANTROWITZ

between on or about September 4, 1999, and on or about November 6, 1999, at the City of Asbury Park, in the County of Monmouth, elsewhere, and within the jurisdiction of this Court, purposely did obtain by deception the property of the State of New Jersey, valued in excess of \$500; that is, the said MAXINE KANTROWITZ did purposely obtain unemployment insurance benefits in the amount of \$3,230.00 by submitting or causing to be submitted documents for unemployment insurance benefits of the State of New Jersey, thereby creating or reinforcing false impressions to the State of New Jersey that the said MAXINE KANTROWITZ was unemployed;

WHEREAS IN TRUTH AND IN FACT, as the said MAXINE KANTROWITZ then and there well knew, she was employed, all contrary to the provisions of N.J.S.A. 2C:20-4, and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Theft by Deception-Third Degree)

MAXINE KANTROWITZ

between on or about April 14, 2001, and on or about June 9, 2001, at the City of Asbury Park, in the County of Monmouth, elsewhere, and within the jurisdiction of this Court, purposely did obtain by deception the property of the State of New Jersey, valued in excess of \$500; that is, the said MAXINE KANTROWITZ did purposely obtain unemployment insurance benefits in the amount of \$3,256.00 by submitting or causing to be submitted documents for unemployment insurance benefits of the State of New Jersey, thereby creating or reinforcing false impressions to the State of New Jersey that the said MAXINE KANTROWITZ was unemployed;

WHEREAS IN TRUTH AND IN FACT, as the said MAXINE KANTROWITZ then and there well knew, she was employed, all contrary to the provisions of N.J.S.A. 2C:20-4, and against the peace of this State, the government and dignity of the same.
